Director's Report - 10.13.2020

Programs – We've continued take and makes through September and into October. They've had up weeks and down weeks, but people continue to seem to appreciate them as a way to interact with their families especially as supplemental material for homeschooling and projects. Even though regulations have lifted to 20 people per 1000 sq. feet for gatherings, we haven't yet made the move toward planning in-person programming because we'd still be limited to our 15 person library capacity and the difficulty in social distancing in a limited space, especially with kids.

Statistics - Our statistics are looking not too bad, even compared to this time last year, except for the computer stats. We have notices more people using personal devices to access the internet rather than our computers.

Building Items - Bob Larr has mentioned to me a couple of times the need for new siding. I've added it to old business as a point of discussion since I know at one time we considered it under strategic planning.

While there has been a lot of confusion on what rules businesses are subject to in the aftermath of the Supreme Court's decision in regards to the Governor's rules, I've opted to maintain our current masks and social distancing and cleaning requirements, especially in the library of the Michigan Health Departments declaration. I believe until we firmly hear otherwise, we will continue to follow the regulations we put in place regarding masks, social distancing, and building capacity.

We also were finally able to purchase the 2 hand sanitizer dispensers to put at each entrance of the library. This was part of the CARES grant we received a few months ago. The supplies to purchase them are finally back in stock, and we are now able to put them in.

Budget Items - This month is our quarterly budget review. I have made a couple of suggestions for our current budget in the income portion because, as we near the end of the year, I have a better idea of where we may or may not receive the funds we originally anticipated. I know there are also areas of our budget where we will not spend the full amount

we had originally anticipated because of being closed and because we aren't doing the full programming lineup that we usually do. I've held off on making adjustments in the expenses area for those particular items until October is done, merely because we do have a couple of larger bills (like Lakeland dues) that have just come in and will appear in the October expenses and therefore give us a better idea of what our expenses will look like as we approach the end of the year.
